

# Fee Schedule for Camp Bartle - Summer 2024 (Jan 2024)

June 23 to July 3, 2024 (Session 3)

These fees should be paid to our Troop Treasurer, Kim Morgan. Please write checks to: "Troop 114B"

**PLEASE PAY BY CHECK...** Make sure is clear that these fees are for Bartle AND exactly who you are paying for (Scout or Parent). If you have a positive balance in your account from Popcorn, Green or Camp Card sales and want that put towards this deposit, please let Kim know in writing.

Also note deadlines, adult registration requirements, late fees and refund policies. We estimate total camp + travel fees of \$580 for every Scout and \$540 for every adult.

## SCOUT CAMP FEE (ESTIMATE January 2024)

- \$75 - Initial Deposit due by November 2, 2024 for every Scout & Adult
- \$275 - \$350 Total - Due by February 8, 2023
- **\$230 - \$580 Total estimated due April 18, 2023**
- **\$580 Total estimated**
- Late fee of \$25.00 if signing up after April 18, 2024.

## LEADER & PARENT CAMP FEES \$75 Deposit due November 2, 2022; Final Payment Due April 18, 2023

- Adult fees will be determined by dividing Bartle's adult fees among those adults attending and adding additional per person costs.
- **We anticipate that an adult attending the full session will have fees of \$540.**

## ADULT REGISTRATION REQUIRED

- **All Adults staying at Camp MUST be registered with the Boy Scouts of America**
- A separate registration fee will be billed to your Troop account.  
(as much as \$84 - prorated depending on when you register)
- Registration Processing take 3-4 weeks, they MUST be filed by May 1, 2024
- NO Adult will be allowed to stay at Camp without being registered

## REFUND POLICY

- **Prior to April 18, 2024:** Full Refund (minus \$75 and any late fees)
- **After April 18, 2024:** No Refunds
