Scouts will be participating in Summer Camp activities at Camp Cris Dobbins. This trip may involve strenuous activity, depending on the specific programs each Scout elects to participate in. All camp program activities, including aquatics, rope climbing, and shooting sports, will be under the supervision of trained camp staff. Make sure you have the appropriate gear as described on the packing list. Spring/Summer camping conditions will be likely so make sure that you have appropriate clothes and sleeping gear. Be prepared!

Due to the uncertainty of the weather, we cannot predict what the conditions will be. Precautions to provide a safe and enjoyable experience will be taken, but there can be no guarantee of absolute safety against injury or accident. In recognition of the inherent risks of attending Camp Cris Dobbins, I (and for or on behalf of my child participant) assume full responsibility for personal injury, accidents and illness, including death, that may occur from my child's (or my) participation.

Social distancing guidelines will be followed. Each participant is required to provide and wear their own face covering as well as bringing hand sanitizer. Please remember that any activity outside of a participant's household increases potential exposure to COVID-19 and other pathogens.
